Classes will be completed online using the Edgenuity online curriculum.

REGISTRATION: ONLINE, VHS website (www.wcsdre1.org/valleyhighschool_home.aspx)

Please register prior to June 6 on the VHS website or by form from the VHS office. Registration will open on May 1, 2019.

Students MUST be registered and fees must be paid prior to class time on June 10 to be enrolled

COST: \$110.00 per course

Payment must be received prior to the first day of class. *(If you have an exceptional financial need, payment for courses can be made by installment. One-half of the total fee must be paid prior to the first day of class. An installment application is available in the VHS Counseling Office. IF you will be paying by installment, please complete the application and then call Mrs. Freehling at 970-350-4201 x 4238 to make arrangements. **Installment arrangements must be made by June 4**)*

CREDIT POLICY: Courses MUST be completed by June 28, 2019 in order for credit to be received. No refunds will be issued for incomplete or failed courses. Courses MAY NOT be continued/finished during the regular school year. Any course for which a student is enrolled but has not completed at the end of the summer session will be issued a failing grade and any completed work deleted.

COMPLETION/ COURSE PROGRESS POLICY: Students are expected to spend time outside of summer school hours to complete coursework. Each week progress in the course(s) will be monitored as follows:

Monday, June 17 – minimum of 33% of course completed (50% by Wednesday, June 19)

Monday, June 24 – minimum of 67% of course completed

Monday, June 26 – minimum of 80% of course completed

If the minimum required coursework is not completed by the dates above, the student may be dropped from the course for incompleteness. ***No credit or refund will be issued.***

ATTENDANCE POLICY: Although the Edgenuity online coursework will be used for credit recovery during the summer session, attendance is mandatory. **Two (2) absences** will result in loss of credit and removal from the course. **Two (2) tardies equal one (1) absence.** No refunds will be issued due to removal from a course for lack of attendance. **Students must have 50% of their coursework completed by the beginning of class June 19** or they will be dropped for non-participation. No refunds will be issued due to removal from a course for non-participation.

Monday, June 24 – minimum of 67% of course completed

Monday, June 26 – minimum of 80% of course completed

If the minimum required coursework is not completed by the dates above, the student may be dropped from the course for incompleteness. ***No credit or refund will be issued.***
